

**Requirements to the Research Articles submitted to the
Central Ukrainian Scientific Bulletin. Economic Sciences**

I. Requirements for the content of the article.

1. *The volume of the article* should not exceed 5-7 pages, including figures and tables.

2. Structure of the article:

1. UDC.
2. JEL Classification
3. Full name, science degree, academic rank, the position of the author (authors).
4. Affiliation, city, country.
5. e-mail of the author (authors).
6. Title.
7. Abstract (5-7 lines).
8. Keywords (3-8 words).
9. Main part of the article.
10. References (standard APA).
11. Extended abstract (not less than 1800 points).
12. Keywords (3-8 words).
13. The date of submitting of the manuscript to the Editorial Board.

3. The article must include such elements:

Statement of the Problem

Analysis of Recent Researches and Publications

Statement of the Objective

The Main Material

Conclusions and Prospects for Further Researches

Each element of the article must begin with a new paragraph, its name should be in black type and should contain such material:

Statement of the problem: the author(s) should indicate the relevance of the article, the content of the research problem in general and its connection with important scientific and practical tasks.

Analysis of Recent Researches and Publications: analysis of studies and publications, which started the study of this problem and are used by the author; unsolved parts of the problem.

Statement of the Objective: the research purpose and the definition of the main problem.

The Main Material: the content of the study with the justification of scientific results.

Conclusions and prospects for further researches: scientific and practical value of the results, implications for a future research in this scientific direction.

4. We recommend using in preparing the abstract the recommendations that was made, for example, by the publisher Emerald Group Publishing (examples of annotations are represented by reference: <http://www.emeraldgrouppublishing.com/authors/guides/write/abstracts.htm?part=2>). For example, it is recommended to disclose such information in the abstract: the purpose of the study, the methodology, research methods used, approaches, findings, scientific and practical value (the value) of the study.

Abstract, which is served before the main text of the article is a shortened (5-7 lines, Times New Roman (Cyr), 10 pt), and is not divided into paragraphs.

Extended abstract should consist of three paragraphs, which should contain: the purpose of the study (2-5 lines); description of the work (5-10 lines), conclusions (2-5 lines). Times New Roman (Cyr), 10 pt.

5. Keywords in both abstracts should be identical.

6. Analysis of recent researches and publications must contain not only simply the names of the authors, who were engaged in the study of this problem, but also references to their scientific works. The authors must set a non-breaking range (this requirement also applies to names that are specified in the main text of the article) between the name and surname.

7. Graphic material (figures and tables) should be numbered, have a title and be accompanied by an indication of the source, which is located to the graphic material - after the title, to the table material - after the table.

For example:

Figure 1.2. Name

Source. Compiled (or designed, calculated) by the author.

or

Source. Compiled (or designed, calculated) on the basis of [] (or using [] on the basis of data []):

We are not recommended to include in the main text of the article the figures or tables that are fully owned by other authors.

The authors must be sure that the information that presented in the figures and tables do not duplicate results described in the article itself.

8. We recommend numbering only those formulas that are referenced in the following text. Other formulas are not recommended to be numbered.

9. It is desirable to avoid the use of abbreviations, which are not widely accepted.

10. Article with a wide list of references demonstrates professional outlook and quality of research. References should contain not less than 8 sources.

11. Bibliography must be formed in APA style under the title: References.

For the preparation of the list of references it is recommended to use one of the most popular standards - APA standard (American Psychological Association (APA) Style).

We recommend to use the examples of References Unit by the rules of the APA-2010, posted on the website of the journal "Demography and social economy» (http://dse.org.ua/archive/references_rus.pdf).
